9. The Future of Ageing, Gender, and Illness in Literature

The field is currently moving toward **Post-Humanist Age Studies**, which examines how technology and medical intervention (bio-hacking, life extension) alter the narrative of ageing. As the global population ages, the "silver economy" is reflected in a "silver canon" of literature. The technical analysis of these texts requires an understanding of **narrative gerontology**—the study of the stories we live by as we age.

By establishing age as a category of literary history, we move away from seeing it as a peripheral concern.
