Proven track record of reducing turnaround time (TAT) by 15% through optimized workflow scheduling in a Part 145 environment."

Aviation maintenance requires a blend of manual dexterity and cognitive diagnostic ability. A resume should categorize these skills to allow for quick scanning by maintenance managers. Below is a structured representation
