

Inventing the American Constitution: A Technical Analysis of Carol Berkin's 'A Brilliant Solution' and the Problem-Solution Framework

The **Great Compromise**(also known as the Connecticut Compromise) functioned as a dual-redundancy system. It ensured that the popular will was reflected in the House of Representatives, while the Senate acted as a stabilizing mechanism, protecting the interests of smaller jurisdictions and preventing a "tyranny of the majority."

4. Engineering Checks and Balances: The Mechanics of Power
