Technical Analysis: Logistics and Terrain Challenges in High-Altitude Warfare

Hussain's writing provides granular detail on the **logistical nightmares** associated with the Kargil heights. The terrain in question—Dras, Kaksar, and Mushkoh sectors—reaches altitudes between 11,000 and 18,000 feet. At these elevations, the technical requirements for troop survival and combat change drastically.

1. Physiological and Atmospheric Constraints

3. The Northern Light Infantry (NLI) Structure
