These elements function as a closed-loop system. If the **assessment** data indicates a gap in understanding, the **instruction** must be adjusted within the **learning environment**, guided by the **curriculum**, and enabled by **classroom management**.

The Technical Mechanics of Assessment Types

A differentiated classroom moves away from the binary of "pass or fail" and toward a continuum of growth. This requires a granular understanding of three primary assessment types and their technical application in the classroom workflow.

1. Pre-Assessment (Diagnostic Evaluation)

K - Know (Facts and Vocabulary)

These are the foundational components—the discrete information that students must memorize or identify. Examples include dates in history, multiplication tables, or definitions of scientific terms. While essential, "Knowing" is the lowest level of Bloom's Taxonomy.

U - Understand (Big Ideas and Principles)

Understanding refers to the "Big Ideas" or essential truths that give the facts meaning. These are transferable concepts. For instance, in a science unit, students might *know* the parts of a cell, but they must *understand* that structure dictates function. Differentiation is most effective when it targets these core understandings.

D - Do (Skills and Processes)

This refers to the observable skills students should be able to perform. This might include writing a persuasive essay, solving a multi-step equation, or conducting a laboratory experiment. Assessment must be designed to specifically measure these "Do" elements without being confounded by unrelated obstacles.

Implementation Field Guide: 7 Steps to Differentiated Assessment

Moving from theory to practice requires a structured approach. Below is a procedural workflow for integrating differentiated assessment into any grade level or subject area.

1. Identify the KUDs: Before designing the unit, clearly define what students should Know, Understand, and be able to Do.

3. Design the "Equalizer" Tasks: Created by Tomlinson, the Equalizer is a mental model for adjusting the complexity of tasks. Adjustments can be made along several scales:

- 6. Slow to Fast-paced

Managing the Data: Grading and Record Keeping

Teachers should maintain separate records for **formative progress** and **summative achievement**. This requires a move toward standards-based grading, where rubrics are used to define levels of proficiency (e.g., Emerging, Proficient, Exemplary) for specific learning targets.
