- **All-Wheel Drive (AWD) and 4WD:** These systems distribute torque to all four wheels, either permanently or on-demand. While providing superior grip, they increase vehicle weight and mechanical complexity.

1.2 Chassis and Frame Structures

The **chassis** acts as the skeleton of the vehicle, supporting all components. Modern vehicles primarily use one of three types of construction:

1. **Ladder Frame:** Two longitudinal rails connected by lateral cross-members. This is common in heavy-duty trucks and SUVs due to its high load-bearing capacity and ease of repair.
2. **Monocoque (Unibody):** The body and chassis are integrated into a single structure. Most modern passenger cars use this to reduce weight and improve fuel efficiency while enhancing safety through controlled deformation (crumple zones).
3. **Space Frame:** A skeletal structure of tubes or extruded sections (often aluminum) to which body panels are attached. This is common in high-performance and racing vehicles.

2. Internal Combustion Engine (ICE) Components and Material Science

The engine is a complex assembly subjected to extreme thermal and mechanical stresses. Material selection is critical to ensuring longevity, performance, and thermal efficiency. 2.2 The Combustion Cycle and Efficiency

The thermodynamic efficiency of an engine is governed by the **Otto Cycle** (for gasoline) or the **Diesel Cycle**. Engineering optimization focuses on the **Compression Ratio (CR)**. Higher CRs lead to better thermal efficiency but are limited by the "knock" limit of the fuel. wheel wells. **Active Grille Shutters:** Closing the front grille when cooling is not needed to streamline the front end.

4. Transmission and Drivetrain Systems

The transmission system's role is to transfer power from the engine to the wheels while maintaining the engine within its optimal operating range. This is achieved through torque multiplication.

4.1 Types of Transmission Systems

1. **Manual Transmission:** Uses a clutch and a series of gear sets (constant mesh). It offers high mechanical efficiency but requires driver input.
2. **Automatic Transmission (Torque Converter):** Uses a fluid coupling to transfer power, allowing the vehicle to stop without stalling. Modern units feature 8 to 10 speeds to maximize efficiency.
3. **Continuously Variable Transmission (CVT):** Uses a belt and pulley system to provide an infinite number of gear ratios, keeping the engine at its most efficient RPM.
4. **Dual-Clutch Transmission (DCT):** Uses two separate clutches for odd and even gear sets, allowing for lightning-fast gear changes without interrupting power flow.

4.2 The Differential

The **differential** is a gear mechanism that allows the drive wheels to rotate at different speeds while the vehicle is turning. This is essential because the outer wheel must travel a longer distance than the inner wheel during a curve. **Limited-Slip Differentials (LSD)** are employed in performance vehicles to ensure torque is sent to the wheel with the most traction.

5. Steering, Suspension, and Braking Mechanisms

These systems are responsible for the ride quality, handling, and safety of the vehicle. They must manage the interaction between the tires and the road surface.

5.1 Steering Geometry

Most vehicles use **Ackermann Steering Geometry**. This design ensures that all wheels trace circles with a common center point during a turn, preventing tires from scrubbing sideways. The **Rack and Pinion** is the most common mechanical linkage, converting the rotational motion of the steering wheel into the linear motion required to pivot the wheels.

5.2 Braking Systems: Disc vs. Drum

Braking is the process of converting kinetic energy into heat through friction. Modern vehicles utilize **Hydraulic Braking Systems** assisted by an **Anti-lock Braking System (ABS)**.

ABS Mechanics: The ABS controller monitors wheel speed sensors. If a wheel is about to lock up (stop rotating), the system pulses the hydraulic pressure to that brake, allowing the wheel to continue rotating and maintaining steering control for the driver.

6. Automotive Electricity and Electronic Control Units (ECUs)
