- **Inappropriate Type Choices**: Using a typeface that contradicts the message (e.g., using a playful script for a technical manual). Solution: Analyze the Typographic Voice. Select typefaces based on historical context and legibility metrics rather than personal preference.

The Synthesis of Concept and Technology

The history of graphic design is not a straight line, but a cyclical process where old ideas are constantly rediscovered and reimagined through new technology. The "100 Ideas" identified by Heller and Vienne serve as the DNA of visual communication.
