### Physically-Based Models

Unlike empirical models like Johnson-Cook, physically-based models use **dislocation density**as an internal state variable. By tracking how dislocations multiply and annihilate during deformation, these models can predict phenomena like dynamic recovery and recrystallization with much higher accuracy, especially when the process involves multiple stages of deformation and annealing.

## Practical Implementation: A Field Guide for Engineers

Nickel-base superalloys, used in the hot sections of gas turbines, are notoriously difficult to process due to their narrow 'processing window.' - **Neglecting Microstructural Feedback:** Modeling the shape change without accounting for how the microstructure affects the flow stress (and vice versa) leads to inaccuracies in predicting press loads and final properties.

## Synthesis of Future Trends in Metals Modeling
