2. Eco-Physiological Adaptations and Dormancy Cycles

The region is divided into **Winter Rainfall** (Western Cape) and **Summer Rainfall** (Eastern Cape and Highveld) zones. - *Brithys crini* (Lily Borer): A moth larva that tunnels into the leaves and down into the bulb core. Solution: Manual removal or the application of *Bacillus thuringiensis* (Bt).
- Mealybugs: These often hide within the bulb scales or tunics. Solution: Drenching with Neem oil or systemic insecticides during the active growth phase.

7. Export Logistics and Phytosanitary Requirements
