Amplitude Modulation (AM)

Frequency Modulation (FM)

FM varies the frequency of the carrier. Unlike AM, FM provides superior noise immunity because noise primarily affects the amplitude of a signal. By using amplitude limiters in the receiver, FM systems can achieve a much higher signal quality, albeit at the cost of significantly higher bandwidth requirements.

Phase Modulation (PM)

PM involves shifting the phase of the carrier. While less common in pure analog form, phase-shift keying (PSK) is the foundation of most modern digital communication protocols, including Wi-Fi and 4G/5G LTE.
