Technical Criteria for Triangle Congruence

1. Side-Side-Side (SSS) Postulate

The **SSS Postulate** states that if three sides of one triangle are equal to the three sides of another triangle, the two triangles are congruent. 2. Side-Angle-Side (SAS) Postulate

3. Angle-Side-Angle (ASA) and Angle-Angle-Side (AAS) Theorems

The **ASA Theorem** requires two angles and the side between them to be equal. Conversely, the **AAS Theorem** states that if two angles and a non-included side of one triangle are equal to the corresponding parts of another, they are congruent. These theorems are frequently applied in triangulation for surveying and navigation.

4. Hypotenuse-Leg (HL) Theorem

Specific to right-angled triangles, the **HL Theorem** asserts that if the hypotenuse and one leg of a right triangle are equal to the hypotenuse and leg of another right triangle, the triangles are congruent. This is a specialized derivation of the Pythagorean theorem.

The Mathematical Mechanics of Similarity

Similarity is governed by the principle of proportionality. For two triangles, ΔABC and ΔDEF , to be similar (denoted as $\Delta ABC \sim \Delta DEF$), the following conditions must be met:

- Angle-Angle (AA) Similarity: If two angles of one triangle are equal to two angles of another triangle, the triangles are similar. Since the sum of angles in a triangle is always 180 degrees, the third angle must also be equal.
- Side-Side-Side (SSS) Similarity: If the lengths of the corresponding sides of two triangles are proportional, the triangles are similar. $\frac{AB}{DE} = \frac{BC}{EF} = \frac{AC}{DF} = k$.
- Side-Angle-Side (SAS) Similarity: If one angle of a triangle is equal to an angle of another triangle and the

sides including these angles are proportional, the triangles are similar.

Calculating the Scale Factor

The scale factor k is the constant of proportionality. It is vital to maintain a consistent order of correspondence when calculating this value. For example, if we are given ΔDEF with sides 9 cm, 12 cm, and 6 cm, and ΔPQR is similar with a corresponding side $PQ = 15$ cm (where PQ corresponds to DE), the scale factor k is calculated as:

$$k = \frac{PQ}{DE} = \frac{15}{9} = \frac{5}{3}$$

Using this factor, one can determine all other dimensions of the second triangle. If $EF = 12$ cm, then the corresponding side $QR = 12 \times (5/3) = 20$ cm.

Advanced Applications: Area and Volume Ratios

The relationship between similar figures extends beyond linear dimensions into area and volume, which is a critical consideration in scale modeling and manufacturing.

The Square-Cube Law in Similarity

When the linear dimensions of a figure are scaled by a factor of k :

- The Perimeter increases by a factor of k .
- The Area increases by a factor of k^2 .
- The Volume increases by a factor of k^3 .

This means that if a model car is built at a 1:10 scale (where $k = 0.1$), the surface area of the model is only 1/100th of the original, and the volume (and often the weight, assuming consistent density) is only 1/1,000th of the original. This principle is vital for engineers when testing prototypes in wind tunnels or hydraulic models.

Procedural Guide: Solving Similarity Problems in Right Triangles

One of the most frequent applications of similarity occurs in right triangles that are divided by an altitude drawn to the hypotenuse. This creates three similar triangles: the original large triangle and the two smaller triangles formed by the altitude.

Step-by-Step Execution

- Step 1: Identify the Triangles. Label the vertices and the altitude. Let ΔABC be the right triangle with the right angle at C , and CD be the altitude to the hypotenuse AB .
- Step 2: Establish Similarity. Recognise that $\Delta ABC \sim \Delta ACD \sim \Delta CBD$ due to the AA similarity criterion.
- Step 3: Set Up Proportions. Use the geometric mean theorems:
 - $CD^2 = AD \times DB$ (The altitude is the geometric mean of the segments of the hypotenuse).
 - $AC^2 = AD \times AB$ (The leg is the geometric mean of the adjacent segment and the whole hypotenuse).
 - $BC^2 = BD \times AB$.

The Core Mechanics of Overlapping Triangles

In many technical problems, similarity is found within overlapping triangles, often created by parallel lines intersecting a triangle (the Basic Proportionality Theorem or Thales's Theorem). If a line is drawn parallel to one side of a triangle to intersect the other two sides in distinct points, the other two sides are divided in the same ratio.
